

1 GOAL

Establish, implement and maintain a process to evaluate the performance of the Environmental Management System (EMS) of Portos do Paraná.

2 APPLICATION FIELD

It applies to all the actions performed by Portos do Paraná, related to environmental management and the integrated management system established in the company.

3 REFERENCE DOCUMENTS

- Federal Law N.º 6.938/1981: implements the National Environment Policy, its purposes and formulation and application mechanisms, and provides other measures;
- Federal Law No 9.605/1998: addresses the criminal and administrative sanctions resulting from conducts and activities that are harmful to the environment, and provides other measures;
- Federal Law Nº 9.966/2000: addresses the prevention, control and inspection
 of pollution caused by the release of oil and other harmful or dangerous
 substances in waters under national jurisdiction and provides other measures.
- National Environment Council (CONAMA) Resolution N

4 TERMS AND DEFINITIONS

Environmental objective: objective defined by the organization, consistent with its environmental policy.

Requirement: need or expectation that is stated, usually implied or mandatory.

Audition: systematic, independent and documented process for obtaining audit evidence and evaluating it objectively, to determine the extent to which the audit criteria are met.

Conformity: meeting a requirement.

Non-compliance: failure to meet a requirement.

Corrective action: action to eliminate the cause of a non-compliance and to prevent

recurrence.

Environmental performance: performance related to the management of environmental aspects.

5 DESCRIPTION

Portos do Paraná's environmental performance assessment process takes place through four main tools:

- 1. Critical analysis of the performance of environmental programs;
- 2. Internal, environmental and risks management audits;
- 3. Independent (external) environmental audits, in compliance with Conama 306 and PGR;
- 4. Evaluation of Antag's Environmental Performance Index (IDA).

Considering the first three assessment tools, the analysis criteria are the environmental objectives and goals, as well as standards/recommendations contained in legal requirements and other requirements. The fourth tool is based on assessment criteria established by the National Waterway Transport Agency (Antaq), observing not only legal requirements, but international good practices.

The environmental objectives and goals established within the scope of Portos do Paraná's activities are, therefore, listed in the table presented below, along with the legal requirements for each goal, related plans and programs and the current situation of meeting the goals / indicators.

5.1 Critical analysis of the performance of environmental programs

The critical analysis regarding the results of the environmental programs is carried out every year, taking into account their objectives and goals, as well as the standards established in the current legislation and/or recommendations of other competent authorities. The responsibility of this evaluation belongs to the technical team of the Environmental Sector from Portos do Paraná (Diramb) and to the company hired to provide technical support for environmental management and the execution of environmental programs. The evidences comprise activity reports (RSA), including notes and observations, proposals for corrections and/or recommendation of a detailed investigation of any NC for the proposal of corrective action.

5.2 Internal environmental auditions

In order to assess the environmental performance for continuous improvement of the IMS, the Environmental Management System is audited every six months by a team of internal auditors from Diramb and/or the company hired to provide technical support for environmental management.

5.3 Independent environmental auditions

Every two years, the Environmental Management System is audited by a team of independent (external) professional environmental auditors certified in the Register of Certified Auditors (RAC) of the National Personnel Qualification and Certification System (SNQC).

5.4 Antag Environmental Performance Index (IDA)

Annually, on a voluntary basis, Portos do Paraná undergoes the assessment of the Environmental Performance Index (IDA) of the National Waterway Transport Agency (Antaq). The index criteria are based on legal requirements and international good practices. Since 2012, it takes place through the provision of information on environmental management by the Environment Manager, on a specific platform by Antaq.

5.5 Improvement actions plan, corrections and corrective actions

When the possibility of improving a process is identified through the application of any of the previous assessment tools, an observation should be made in order to improve it. The same should occur in the face of unmet goals or unmet requirements, which are responsible for registering non-compliance and proposing correction and/or investigating for proposing corrective action for complete and comprehensive sanitation of non-compliance. Regardless of the type of deal needed for registration (observation, correction or corrective action), all must be managed through an Action Plan setting out the measures to be taken, with the establishment of a schedule detailing all the steps to be followed for full accomplishment.

5.6 Review of objectives and goals/indicators

The environmental objectives and goals established in this procedure will be reviewed every two years and/or when there is a change in the environmental programs and plans executed by Portos do Paraná. It will be associated with the IMS risk assessment process (environmental aspects, hazards, legal requirements and other requirements). The Environment Management Sector and its technical team is responsible for reviewing the objectives and goals, and the person responsible for its final approval is the Environment Manager.
